INTRODUCTION

Elizabeth Glaser Pediatric AIDS Foundation (“EGPAF” or “Foundation”), a non-profit organization, is a world leader in the fight to eliminate pediatric AIDS. Our mission is to prevent pediatric HIV infection and to eliminate pediatric AIDS through research, advocacy, and prevention and treatment programs. OBJECTIVE OF THE ASSIGNMENT | SCOPE OF WORK | EXPECTED DELIVERABLES

EGPAF seeks to contract with a reputable Vendor to immediately meet our current connectivity needs (with the possibility of fulfilling future needs as they arise) in support of an ambitious national Electronic Medical Records (EMR) initiative. It is anticipated that the selected Vendor can assess our requirements, develop a comprehensive and effective solution to implement at all 752 PEPFAR-supported MOH Clinics throughout Malawi (see *Attachment 1*), and eventually implement and install, in coordination with the necessary Foundation staff, all necessary infrastructure at each site to reflect its proposed solution(s).

More specifically, the selected Contractor is expected to offer a fast and affordable Carrier Backbone network services to cover 752 clinics across the 28 Districts in Malawi to support regular and incremental data transmission from the Clinics/health facilities to a Central Data Repository hosted at the Ministry of Health. The winning Contractor will be responsible for installation of last mile connection to connect each health facility to the backbone network, including configuring Point-to-Point connections between the health facility and the Central Data Repository. Given the size and ambitious scope of this endeavor, there is potential for a long-term partnership to develop depending on the availability of future funding opportunities supporting our project.

In recognition of this, EGPAF seeks a partner who can and will meet the following goals:

- ✓ Have capacity to lease network infrastructure and provide proof of capacity to connect all 752 clinics; a list of Clinics with GPS points is provided as *Attachment 1* to this solicitation.
- ✓ Offer competitive lease pricing and unique services, speeds, and network performance significantly matching international standards. For example, providing hundreds of megabits or gigabit speeds in the core backbone carrier, providing symmetrical services, providing services that continue operating when commercial power fails, providing stringent service level agreements, and providing direct connectivity between locations with OSI Layer 2 flexibility for our network team to have full control of the virtual network created.
- ✓ Possesses a full understanding of the network infrastructure leasing business model (e.g. subscription-based model).
- ✓ Respond to the needs for large and small Health Facilities connected to the Backbone network.
- ✓ Applicants should include in its proposal details of those sites where infrastructure is already available and where installations will be required and timelines to activate the sites.

- ✓ Supports unfettered access: The leased network will deliver an unfettered data offering that does not impose caps or usage limits on one use of data over another (i.e. does not limit streaming or upload and download). All application services (data, voice, and video) are equally able to transmit their services.
- ✓ Vendors need to indicate electricity requirements for equipment and if power back up will be included with the equipment.
- ✓ Vendors are required to provide the ability to monitor connectivity efficiencies and down time remotely and ensure monitoring of last mile packet latency.

Preferred Business Model: Our preferred business model is one in which the EGPAF and the selected Contractor will design and construct virtual networks with last mile connections using the Partner's network infrastructure throughout the entirety of the 741 sites. EGPAF will lease access to the partner's infrastructure to create a backbone network across the country. In this model, the Contractor will also be responsible for the network electronics required for last mile connectivity, backup power services for the installed infrastructure, and monitoring and maintenance of the last mile network infrastructure.

Network Design and Construction Parameters: The winning vendor must include the following deliverables in the Phase I Network Design and Specification work product:

- ✓ The locations are required sites to be included in the network design and route plan. The list of sites may expand at the discretion of EGPAF after consultation with the selected Network Partner.
- ✓ The Design must include recommendation(s) for location and placement of the headend along with detailed specifications and equipment required for connectivity to Spread Networks Backbone (or alternate backbone network provider of equal performance and latency). The Design must also specify all necessary communications and integration equipment. Final determination of the network route will be made by EGPAF after reviewing submitted proposals and discussions with the Network Partner.
- ✓ In addition to the required sites, the Network Partner or vendor will be requested to engage in some long-term planning discussions with EGPAF representatives to assist in assessing future network alternative deployments. The final deliverable for Phase I will not incorporate the design or engineering for the future network alternatives but will assist the EGPAF and Network Partner/vendor in understanding how to position the current network design to accommodate future expansion.
- ✓ The Vendor will evaluate the existing site-by-site local networks and provide recommendations for how best to integrate or replace the current networks in order to allow connectivity to the backbone. This analysis will include review and evaluation of existing technology, topology, communications equipment, ongoing support costs, and capital cost and outage history.
- ✓ The Vendor must produce comprehensive computerized design maps, detailed CAD drawings and any necessary construction drawings for the network routes, including location and specification of any communications equipment necessary to meet the performance standards of a fully functional backbone carrier network.

Standard of Services: All Services to be provided by Contractor shall be performed with promptness and diligence in a professional manner and at a level of proficiency to be expected of a Contractor with the background and experience that the Contractor has represented in its bid. EGPAF shall provide such access to its information, property, and personnel as may be reasonably required in order to permit the Contractor to perform the Services.

Operational Capabilities: EGPAF now invites eligible vendors/firms to submit competitive proposals for the applicable deliverables described above. **Failure to provide a solution or quote for any of the items or meet the minimum required specifications as listed may disqualify a bidder from selection.**

The Foundation currently has an immediate need for the initial scope described in this RFP; however, it is anticipated that the Foundation may need to expand the eventual agreed-upon solution to additional sites

throughout Malawi in the future, but the exact needs cannot be determined at this time and are contingent on the availability of future funding. In recognition of this, a **Firm Fixed Price Contract with Option Rates** will result from this solicitation (but is subject to change depending on the selected Contractor and proposed solution). After the initial contract assignment is satisfactorily implemented, the Foundation may, at its discretion, exercise its option in order for the Contractor to provide its solution at additional sites at a fixed option rate proposed by the selected vendor in response to this RFP and captured in the terms of the initial Contract.

EVALUATION CRITERIA AND SUBMISSION REQUIREMENTS

The Foundation will accept bids from the qualified vendor(s) that offer the **BEST VALUE** to the Foundation (i.e. the vendor that provides the most economically advantageous goods and/or services to the Foundation and meets the minimum required specifications stated in this solicitation).

All proposals will be evaluated against the below Evaluation Criteria. Each proposal should contain the items listed in the Submission Requirements column in the following chart. Please submit your Submission Requirements in the order they appear below in order to assist the Foundation is conducting a comprehensive and transparent evaluation selection.

Failure to provide any of the above Submission Requirements may be considered non-responsive and disqualify the applicant from final selection.

At its discretion, the Foundation may conduct further activities with interested bidders after they have submitted a proposal and the submission deadline has passed) in order to perform a more comprehensive assessment of the bids. This may include, but is not limited to, shortlisting applicants, requesting additional information from bidders, contacting references, performing site visits, inviting potential bidders to present its proposed solution to the Foundation's selection committee, etc.

Completed submission packages must be delivered to the Foundation's main office address listed in this solicitation and addressed to EGPAF Internal Procurement Committee.

The deadline for submission is **Friday, 17 January 2020 at 11am**. Any late submissions may be disqualified from selection.

Please note it our best intent to comply with the above timeline, but unavoidable delays may occur.

ADDITIONAL INFORMATION

It is anticipated that there will be a requirement for an initial contract to deliver the solution to the initial 752 sites, with the possibility of additional sites or related services needed after the initial contract assignment has been completed. As indicated above, a **Firm Fixed Price Contract with Option Rates** is anticipated from this solicitation (but is subject to change depending on the selected Contractor and proposed solution). After the initial contract assignment is satisfactorily implemented, the Foundation may, at its discretion, exercise its option in order for the Contractor to provide its solution at additional sites at a fixed option rate proposed by the selected vendor in response to this RFP and captured in the terms of the initial Contract.

Each option exercised will, unless determined otherwise after the proposals are reviewed, will coincide with the quantity of additional sites potentially requested to implement the selected solution. If you are able and should additional funding become available and the Foundation wishes to exercise its option to extend this contract to include additional sites, please include with your financial proposal either:

- 1) The fixed Contractor rates that will be applied to perform the similar provision of equipment and services in the subsequent option sites (s); or
- 2) The maximum percentage with which those rates will increase (for example, the rates in the attached quote will increase no more than 1.5% in the next assignment should the Foundation wish to exercise this option).

If not otherwise specified in the quote, bidder agrees to the firm fixed rates for each option requested in this solicitation.

The option rates will be included in the initial contract(s) agreed upon by both parties. If a bidder is unable to provide a priced option at this time or should any of the services offered by the vendor become unavailable, or unavailable at the unit rate originally proposed, the contractor will inform EGPAF of those issues prior to the exercise of the next option. Pricing shall otherwise remain fixed at the originally agreed-upon rates.

KEY CONTRACT TERMS

The following Terms apply to all Requests for Proposals (RFP), unless otherwise stated in the final agreement executed by both parties, all contracts issued by the Foundation. Preference will be given to vendors who can meet Foundation terms. Any exceptions to the requirements or terms of the solicitation must be noted in the submission.

- 1) **PENALTIES FOR LATE DELIVERY.** Given the urgency of this procurement, the Foundation will be enforcing strict penalties for any Supplier that is unable to deliver the required services as agreed upon by both Parties upon issuance of the final Contract. Should the agreed-upon delivery date(s) not be met in the case of fault of the Vendor or any of its third party partners, the Foundation shall be entitled to demand payment of late delivery penalties amounting to (1%) of the value of the resulting contract and up to a maximum amount of (15%) of the entire value of the resulting contract. Penalties will start if delivery has not been completed after five (5) business days of the required Delivery Date and will incrementally increase each day thereafter. If 14 calendar days have passed and delivery still has not been completed, the Foundation will have the right to cancel an order without penalty and receive full repayment for any potential costs already incurred and paid to the Vendor (unless written agreement from the Foundation is authorized for an extended Delivery Due Date). If the selected Supplier only completes partial delivery of the full order promised for a specific Delivery Due Date, penalties will only be enforced on the portion not delivered.
- 2) Participation in this solicitation is open to all legal contractors. These terms refer to all nationals and to all legal entities, companies or partnerships constituted under, and governed by, the civil, commercial or public law and having their statutory office, central administration or principal place of business. A legal entity, company, or partnership having only its statutory office must be engaged in an activity which has an effective and continuous link with the economy.
- 3) These terms apply to all bidders and any contractors or members of a consortium. To be eligible for participation in the tender procedure, bidders must prove to the satisfaction of EGPAF that they comply with the necessary legal, commercial, technical and financial requirement and are able to carry out the resulting contract effectively.
- 4) EGPAF shall use its best endeavours to ensure that funds provided under this tender do not provide direct or indirect support or resources to organizations and individuals that are associated with terrorism, promote or advocate the legalization or practice of prostitution or sex trafficking, or provide assistance to drug traffickers. If, during the course of this tender, EGPAF discovers any link whatsoever with any organization or individual associated with any or all of these, they shall be excluded or disqualified from the tendering process.
- 5) All applicants are required to be registered and comply with all the laws of doing business in the applicable country where services will be rendered. The Foundation may, at its discretion, require the presumed winner of the procurement to provide a copy of a valid registration certificate and/or tax compliance (i.e. VAT) prior to awarding of the final contract. Failure to provide this information at that time may automatically disqualify a Vendor from selection.
- 6) All quotations, proposals, and/or communications should be identified by the unique RFQ or RFP Reference Number reflected on the first page of the solicitation document. Failure to comply with this requirement may result in non-consideration of your submission.
- 7) Any quotations or proposals not addressing each of the submission requirements listed in the solicitation may be considered non-responsive and disqualify the applicant from final selection. Any exceptions to the requirements or terms of the RFQ or RFP must be noted in the final submission. The Foundation reserves the right to consider any exceptions to be non-responsive.
- 8) Late submissions may not be considered.
- 9) All proposals and/or quotes should be valid for a minimum of 90 days.

- 10) The RFP is not an offer to enter into agreement with any party, but rather a request to receive quotations/proposals from person(s) interested in providing the goods/services outlined in the released solicitation document. Such submissions shall be considered and treated by the Foundation as offers to enter into an agreement.
- 11) The Foundation reserves the right to reject all submissions, in whole or in part, enter into negotiations with any party, and/or award multiple contracts.
- 12) The Foundation shall not be obligated for the payment of any sums whatsoever to any recipient of the solicitation until and unless a written contract between the parties is executed.
- 13) Transport/distribution costs of any goods/services to the required site(s) must be included in the quotation. If not included in the quote, the quoted prices submitted will be assumed to be inclusive of such costs.
- 14) No extra charges of any kind will be allowed unless specifically agreed to by the Foundation in writing.
- 15) Unless otherwise specified in the final contract, full payment will be made by the Foundation to the Vendor within 30 days of receipt of invoice from the Vendor and either delivery of goods or completion of required deliverable. If applicable, within this 30 day period, the Foundation will inspect the commodities or services performed to verify the acceptable receipt of goods/services as promised by the submitted quote or notify the Vendor of any problems with the goods/services that were not caused by the Foundation's negligence or misuse. If the goods/services provided to the Foundation are deemed unacceptable or fail to meet any of the conditions or specifications described in the submitted quote, the Foundation will have the opportunity to cancel the order without penalty and receive full payment for any potential costs already incurred and paid to the Vendor.
- 16) The goods/services will be provided at the selected Supplier's premises unless otherwise requested and authorized by the Foundation. Payment will be made via check or electronic transfer.
- 17) Upon selection and execution of a final contract, Vendor will deliver the goods and/or services within a specified timeframe captured in the agreement.
- 18) Should the agreed delivery date not be met in the case of fault of the Vendor, the Foundation shall be entitled to demand payment of late delivery penalties amounting to (1%) of the value of the resulting contract and up to a maximum amount of (5%) of the entire value of the resulting contract. The Foundation will also have the right to cancel a contract without penalty and receive full payment for any potential costs already incurred and paid to the Vendor.
- 19) All items or deliverables provided to the Foundation must be furnished for the use of the Foundation without royalties or any additional fees.
- 20) All items or materials will be owned exclusively by the Foundation.
- 21) EGPAF reserves the right to terminate the final contract should the selected bidder be unable to fulfill its expected obligations.
- 22) By submitting a bid, all vendors certify that the person(s) involved in the preparation and collation of the proposal and/or quotes were or are in no way associated or have any Conflict of Interests with the initial preparation of the solicitation, the tender documentation, or the subsequent evaluation, assessment, analysis, management, and decision-making process of this tender.

- 23) Equal Opportunity Notice. The Elizabeth Glaser Pediatric AIDS Foundation is an Equal Employment Opportunity employer and represents that all qualified bidders will receive consideration without regard to race, color, religion, sex, or national origin.
- 24) Ethical Behavior. As a core value to help achieve our mission, the Foundation embraces a culture of honesty, integrity, and ethical business practices and expects its business partners to do the same. Specifically, our procurement processes are fair and open and allow all vendors/Contractors equal opportunity to win our business. We will not tolerate fraud or corruption, including kickbacks, bribes, undisclosed familial or close personal relationships between vendors and Foundation employees, or other unethical practices.
